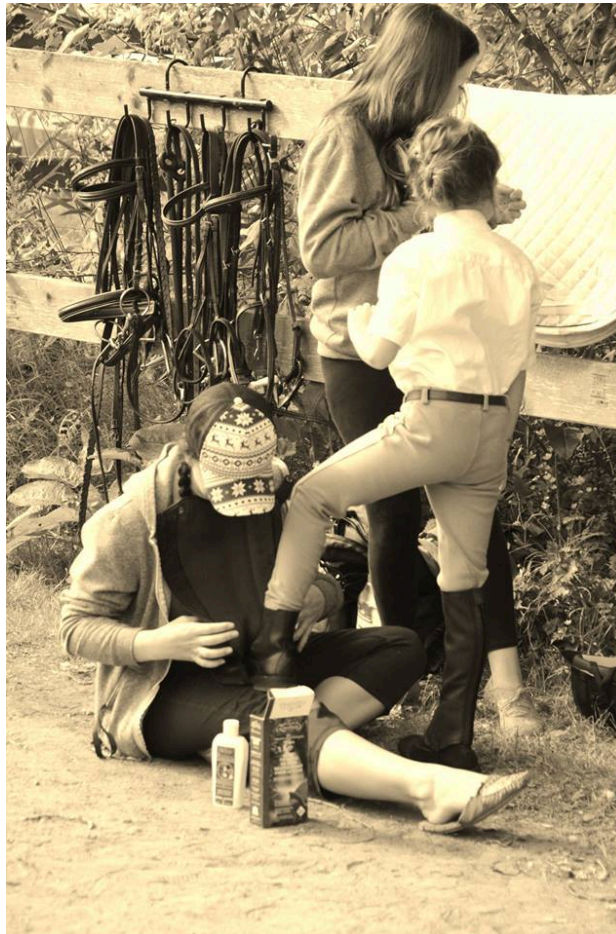

**Entry Rules:** One form per rider, and number per horse. All exhibitors **MUST** have and attach a copy of their current HCBC #

**Late Entry Fee:** \$25.00 for all entries received after 5:00PM on the Monday before the show.

**Scratches:** Exhibitors cancelling after show deadline shall forfeit their entry fees except in the case of disability of entry. Entries shall be refunded upon presentation of a Doctor's or Vet's certificate.

**Adds & Transfers:** Horses entered by the closing date that wish to switch, scratch or add classes will be charged a \$5.00 office charge per change sheet.

Stabling is available on a limited basis. Priority will be given to exhibitors who must travel the furthest and those exhibitors who enter the earliest. Any horses staying overnight on the farm must have emergency contact information posted on stall door.

**HCBC:** All competitors MUST be members of Horse Council BC. Please attach a copy of current membership cards to entry.

**Attire:** Formal show attire required for hunters, hacks, and jumper classics. Braiding is optional and not required for schooling show. Riders MUST wear ASTM/SEI approved helmets with fixed harnesses at all times while mounted on the grounds. Competitor numbers must be visible.

**Points:** 1<sup>st</sup>-7, 2<sup>nd</sup>-5, 3<sup>rd</sup>-4, 4<sup>th</sup>-3, 5<sup>th</sup>- 2

Ties for championships will be broken as per EC rules. In case of only 1 or 2 entries in a class/division, the classes/division will be combined and scored with another similar division.

**Ribbons:** Awarded from 1<sup>st</sup>-5<sup>th</sup>. Division Championships and Reserve Championships will be awarded in all divisions.

Classes on Saturday/Sunday will be run open card. Coaches and competitors must be responsible for signing up their rotations, which will be organized '1<sup>st</sup> come' basis. Hunters/Hacks will be shown in the sand or hog fuel ring depending on number of entries.

SHOW COMMITTEE RESERVES THE RIGHT TO COMBINE, ALTER OR CANCEL ANY CLASS. QUESTIONS / CONCERNS ARE TO BE ADDRESSED TO SHOW MANAGER. SHOW COMMITTEE'S DECISIONS ARE FINAL. Protests must be submitted in writing to the office with a \$50 deposit (as per EC rules)

FEI Article 270 12.2 Version – The Joker is not part of the main course. After the fixed time has expired, the bell is run to end the Athletes round. The Athlete must cross the finishing line to have his time recorded he then has 20 seconds in which to attempt the Joker once. Only one attempt at the Joker is allowed. 200 points are awarded if this obstacle is jumped correctly, but if it is knocked down 200 points must be deducted from the total points obtained by the Athlete.


